INDEMNITY FORM

MACANETA BEACH RESORT WARNS ALL HIRERS THAT KAYAKING ACTIVITIES INVOLVE INHERENT RISKS, DANGERS AND HAZARDS.

The signing of this 'warning' or 'risk' document is an acknowledgement that the hirer(s) is/are aware of the inherent danger involved in kayaking activity. In the event that negligence on the part of the hirer(s) results in injury or loss the hirer(s) is not covered by Macaneta Beach Resort Kayaking Adventure's.

The Hirer:

- 1) Acknowledges having inspected the goods at the commencement of the hiring term.
- 2) Shall not hold the owner liable for any damages or injuries arising from any defect or deficiency in the design, manufacture or condition of the goods.
- 3) In the event that a kayak, paddle or personal floatation device (PFD) is returned in a damaged condition, the hirer agrees to cover the cost of repair or replacement at the discretion of the management.
- 4) agrees to limit his/her use of the goods to the hire limits (within approximately 300m from the coastline) and to obey all reasonable instructions given by the owner. Where kayaks are being used for fishing purposes, it is vitally important that anchors are used and kayaks avoid being dragged out by a catch.
- 5) agrees to cover any costs incurred through the need for emergency or coastguard services.
- 7) acknowledges having received a copy of this agreement at the commencement of the hiring period.

AGREEMENT FOR HIRE

HIRING: The hirer shall pay the fee as outlined below during the term of hire indicated for the use of kayak/s or kayak/s. All kayaks rented include the use of a floatation device and a paddle.

RETURN: The hirer shall return the goods in good order and condition on or before the expiration of the hire term. In the event that the goods are not returned on time the hirer agrees to pay a late hiring fee at the rate of _____ Mts per hour for plastic kayaks until the goods are returned to the owner.
